NOTICE TO BIDDERS

Sealed bids will be received by the Dodge County Highway Superintendent, Dodge County Courthouse, 435 N Park Ave., Room 204, Fremont, Nebraska, 68025 until Monday, March 25, 2019, at 11:00 a.m. CST, for bridge rehabilitation of Structure No. C002732025, and other work incidental thereto, located between Sections 13/24-T19N-R9E in Dodge County, Nebraska. The sealed bids are to be plainly marked "Attention: Dodge County Highway Superintendent, Dodge County Bridge, Structure No. C002732025, Dodge County, Nebraska".

The sealed bids are to be sent or submitted to the Clerk of Dodge County, Dodge County Courthouse, 435 N Park Ave., Fremont, Nebraska, 68025.

The work shall include all labor, materials, transportation and equipment required for abutment reconstruction, installation of new grade beams, new approach pavement and new approach guardrail at both ends of the bridge.

Proposals must be submitted on the forms furnished with the Bid Documents. **Please only submit Divisions 5 and 6.**

Each bidder will be required to submit with his proposal a Bid Bond or Certified Check made payable, without condition, to the County Treasurer of Dodge County, Nebraska, in an amount equal to five (5) percent of his proposal.

The bidder to whom the contract is awarded shall furnish within ten (10) days after the award a surety bond or bonds in a sum equal to the full amount of the contract. The form of the bonds and surety shall be acceptable to the Dodge County Board of Supervisors.

The bidder will include an estimated time of beginning and completion for the project with the proposal. The Contractor will be allowed 45 calendar days for completion of the site. The Contractor may begin work after June 1, 2019. The required completion date of the project is September 1, 2019.

The Board of County Supervisors reserves the right to reject any and all bids or to waive any irregularities in bids.

Awarding of the Contract will be in accordance with the eleven points enumerated under "Competitive Bidding; Consideration", COUNTY PURCHASING ACT, N.R.S. Sections 23-3101 through 23-3114 and any competitive bidding requirements of Nebraska Statutes 16-321, et. seq., and the Dodge County Board of Supervisors will, at their discretion, award based on the lowest or best bid.
