



Colorado Ave, Fremont, NE **68025).** April is the Director for Fremont Children's Academy Inc., which offers educational childcare and family support services here in Fremont. She started the company in 2005 after working eight years for the State of Nebraska as an Independent Family Support Contractor.
- First Term Kathy Kneifl as Family Wellness Representative (2203 East Dodge Street, Fremont, NE 68025). Kathy retired in 2018 from UNL Extension as a SNAP-Ed Assistant Educator, where she worked serving Dodge County and surrounding counties for eight years. She worked with low income audiences and helped build a successful expansion of nutrition services offered to the residents of Dodge County as well as other counties assigned to the position. The current program grew from a staff of one assistant to three full time employees due to the community outreach and the partnerships Kathy developed. Prior to her work at the University, she was with Three River's Health Department as a specialist in Environmental Health and wellness as well as headed up the Emergency Response Division during the H1N1 threat and developed response plans for the three county service area. Before she changed her career to the public health arena, Kathy was a WIC Nutritionist/ Director for Northeast Nebraska Family Health Services for eighteen years. She was also on the core committee who developed the Dodge County Collaborative Team and the workgroup to bring public health services to the county. She currently serves as a board member for Life House (Care Corps/Low Income Ministry) and previously served on the Dodge County Extension Board from 2003-2005.
