This is always an important member meeting for purposes of discussing developments in the past year developments which included continued membership growth. This reaffirms our belief that NIRMA's strength continues to be its membership, now 101 members strong and growing.

The meeting agenda will also include reports on the 2019 operations, claims and financial status of the pool and what lies ahead in 2020. The Nebraska Intergovernmental Risk Management Association (NIRMA) is soliciting nominations for four (4) positions on the eleven-member Board of Directors. The term of office is three years and will commence January 1, 2020.

Individuals interested in being nominated should recognize that a time and travel commitment will be necessary for service on the NIRMA Board. A minimum of four Board meetings are held each year, including an organizational meeting early in the year, followed by separate meetings in the spring, summer and fall. All Board members serve on at least two committees which requires additional time and in-person or conference call meetings. NIRMA does reimburse all Board members for business-related travel costs and also pays a per meeting per diem.

Those <u>eligible</u> to be nominated and serve on the NIRMA Board must be <u>elected or appointed officials employed</u> by NIRMA member counties or other member public agencies. See Neb.Rev.Stat.§44-4306 (2)(a)(i).

If any eligible elected or appointed official from your county or other member agency is interested in seeking one of the four Board positions up for election this year, please refer to the attached general information sheet and complete and return to me the Application/Nomination Form which is also attached. These must be received in the NIRMA office by the close of business on Thursday, September 12, 2019. These nominations will then be shared with our Nominating Committee and it is the Nominating Committee that is charged with presenting a slate of candidates to the membership. Nominations from the floor during the upcoming October 4 Membership Meeting in York will be permitted, but we will be unable to include any such names on the pre-printed ballot. It is important to remember that each member county and other member agency has a vote in the election process, and a properly designated representative from your entity must be present at this meeting in order for your entity to cast its vote in the election.

## General Information and Application/Nomination Form for Board of Directors

The NIRMA Board of Directors has the responsibility for setting direction, establishing policy, and overseeing the activities of NIRMA.

Terms of Office: Directors shall serve for a term of three years, unless being appointed to fill a vacancy in which case the appointment is effective through the unexpired balance of the term for the vacancy being filled. Directors shall thereafter be eligible for reelection and there is no term limitation.

### Duties of the Directors:

- Directors will serve on at least two committees while on the Board of Directors and must be willing to serve on other committees or task forces when requested by the board chair.
- Directors will be responsible for the review and, at times, preparation of material for presentations at Board and committee meetings.
- Directors are also responsible for the approval of insurance contracts, rates and formulas, budget, investment policies, and distribution of assets, among other duties.
- Directors will attend all Board and assigned committee meetings. There are at least four Board meetings annually, along with various committee meetings, some of which are handled by conference call.
- Directors will be involved in various NIRMA meetings as facilitators, speakers or presiders and as representatives of the Board of Directors be in regular contact with members and others.

Expenses/Support: NIRMA will reimburse a director for expenses incurred for travel, lodging, and food for official NIRMA business. Also included:

- Directors receive no salary, but do receive a per diem for each meeting which varies depending
  on whether it is a Board or committee meeting and further by whether it is an in person or
  teleconference meeting.
- Directors and officers liability insurance to protect Directors from decisions related to his or her responsibilities as a NIRMA director unless relating to criminal or fraudulent actions.

Qualifications: NIRMA bylaws require that a nominee for director must be an elected or appointed official employed by a NIRMA member county or other member public agency.

## Selection Process:

The Nominating Committee presents to the membership a slate of candidates for election, or in the event of a vacancy, presents those candidates to the NIRMA Board.

#### The selection process

- is guided by evidence of a variety of attributes including experience, integrity, accountability, informed judgment, skill sets, geography, among others.
- is governed by the NIRMA bylaws which seek to have a Board representative of the membership base profile and diversity.
