Another Round of Mitigation Projects are being reviewed by NEMA and the Governor's Task Force. The date for the submission of Notice of Interest (NOI) is February 18th. If your jurisdiction (eligible applicant) has identified a project please consider submitting an NOI.

NEMA and the Governor's Task Force are currently prioritizing projects to develop full FEMA HMGP applications, with specific interest in identifying **community flood mitigation projects.**

NEMA is reaching out to Dodge County as one of the most impacted counties from the 2019 winter storms and flooding events. Flood mitigation could include (outlined by NEMA):

- Stormwater management projects, including the construction, installation, or improvement of culverts, drain pipes, pumping stations, floodgates, and detention or retention basins
- Flood protection measures for water and sanitary sewer systems or other utility systems
- Slope stabilization or grading to direct flood waters away from homes, schools, businesses, utilities, or governmental facilities
- Vegetation management for riverian, riparian stabilization
- Flood protection and stabilization measures for roads and bridges
- Floodwalls
- Large-scale channelization of a waterway

Federal funding is available for up to 75 percent of the eligible project costs. The remaining **25 percent must be derived from local match sources**.

Hazard Mitigation Grant Program (HMGP)-

HMGP funds (404) are available following a Federally Declared Disaster Declaration for the State of Nebraska. 75% of project costs are reimbursed. The process (truncated)-Notice of Interests (NOI) submitted to Nebraska Emergency Management Agency (NEMA)->Governor's Task Force Reviews-> Project is either "stacked" or approved-> If approved-Project Application Completed at local level and submitted to NEMA-> once approved by NEMA, project submitted to Region 7 Federal Emergency Management Agency (FEMA) for review-> FEMA will send an approval letter. You typically get an additional 20-36 months to complete the project from the date of approval on the letter. The jurisdiction does have the option not to go through with the project without

penalty. Additionally, you can request a project extension (with justification) if necessary.

The first step is to complete the NOI. NOIs are reviewed by a Governor's Task Force following a disaster declaration in the State and when mitigation grant funds are available. There is no guarantee the Task Force will approve to fund the project.
