Mr. Booth shared with the Board the response he received from John Holdenried of Baird Holm to questions posed to the attorney's relating to the potential of closing/terminating the Pension Plan (copy of questions and responses attached to original minutes).

Pension Fund Model - Mr. Booth shared with the Board updated plan termination forecasts provided by Silverstone. The plan termination forecasts have been updated to include a column with the net present value (NPV) of the future contributions based on an annual 4.0% discount rate applied to each future year's contribution. The comparison of the "NPV of contributions" and the "termination shortfall" columns indicates the year the Plan is assumed to be fully funded on a termination basis based on key assumptions. This was presented as informational and no action was taken at this time.
