

DISTRICT I - Precincts 1A, 1 C, 1 E, 4D within the City of Fremont, and, composed of 5,326 residents

DISTRICT II - Precincts 3A, 3B, 3C, and 3D within the City of Fremont, composed of 5,350 residents

DISTRICT III - Cities of Hooper and Scribner, Townships of Hooper/Winslow, Logan, Everett, Cuming, Pebble, Webster, and Nickerson, composed of 5,212 residents

DISTRICT IV - City of North Bend, Townships of Pleasant Valley, Ridgeley, Union, Cotterell, Maple, Platte West, Platte East, and Elkhorn Township composed of 5,125 residents

DISTRICT V - Precincts of 4A, 4B, 4C, and 4E within the City of Fremont, composed of 5,424 residents

DISTRICT VI - Precincts of 1 D, 2C, 2D, and 2E within the City of Fremont, composed of 5,255 residents

DISTRICT VII - Precincts of 1 B, 2B, 2A, and 3E within the City of Fremont, composed of 5,472 residents
