Your sponsorship allows the Council to develop and implement projects which improve the quality of life in Burt, Cuming, Dakota, Dodge, Thurston and Washington counties. In 2021, the RC&D Council completed 7 projects including:

- A Household Hazardous Waste collection in Blair with financial help and support from Cargill and the Papio-Missouri River NRD. There was a record turnout of 197 vehicles bringing over 11,200 lbs. of waste. Twenty-four volunteers from Cargill, Papio-Missouri River NRD, City of Blair, and the Nebraska Loess Hills RC&D Council helped make this collection a success.
- An Electronic Waste collection in Bancroft in July. Over 3400 lbs. was collected from 23 households. Six volunteers helped unload computers, TV's and other electronic waste. 95-98% of the material collected will be recycled.
- The coordination with Jackson Pump & Pantry in mounting a tourism rack in their foyer. It will hold brochures of attractions to see along the Lewis & Clark Scenic Byway.
- The work with the community of Pender to get a new sign put up to advertise canoe access for the Logan Creek.

In 2021, RC&D Council Board members and community volunteers organized by the Council donated more than 930 hours to RC&D projects in our local communities. In addition to completing 7 projects, these efforts furthered progress in other ongoing projects. Your support made this possible!
