1. WELCOME

2. MINUTES

3. FINANCE & ACCOUNTING

FY22 Financial Audit - Justin Hope with Eide Bailly (formerly Seim Johnson) updated the Board on the Firm. Effective July 25, 2022, Seim Johnson merged with Eide Bailly, a Top 25 CPA firm based in Fargo, North Dakota. Mr. Hope presented the Fiscal year 2022 Financial Audit and explained the new accounting principles, GASB 87, related to leases. Based on the structure of the Fremont Health and Nebraska Methodist Health System transaction in 2018 and the new accounting principles, GASB 87, the transaction will need to be recast as a lease and not a sale on the Financial Statements. A revised draft of the FY 2022 Financial Audit will be provided for the October meeting.

4. PENSION FUND & PLAN

While there was a gain in investments in July, Markets saw a loss in August. Investors are optimistic.

5. EXECUTIVE DIRECTOR

Mr. Jelkin stated the Dodge County Board of Supervisors reappointed Larry Shepard to a six-year term as a trustee of the Fremont Community Health Resources Board. Mr. Jelkin is working with FNIC (formerly Harry Koch Company) on insurance renewals for 2023.

6. OTHER ITEMS

Upcoming Meetings - The Board discussed the November meeting date being early in the month. It was decided to not move the date of the meeting and to meet on November $7^{\rm th}$ as scheduled.
