Called the Contractor and the Dodge County Highway Department, hereafter called the County for applying centerline and edge striping to various hard surfaced roads of Dodge County located throughout the county conforming to the following requirements:

1. This Agreement and Specifications shall be a sealed bid and opened January 30, 2023 at 11:00 A.M. in the office of the Dodge County Highway Department, Room 204, 435 N. Park, Fremont, NE 68025.
2. The County will furnish a map showing the locations of the roads to be striped.
3. The County will furnish one employee to assist in the striping operation.
4. The yellow centerline and white edge stripe shall conform to the State of Nebraska width, length and spacing.
5. The paint to be used shall meet State of Nebraska specifications as traffic paint for striping.
6. The paint shall be applied on a clean, dry surface.
7. The paint shall be applied with reflective beads at the rate recommended by the State of Nebraska.
8. The amount of miles of centerline striping shall be **58.75 miles** more or less miles and the amount of edge striping shall be **45.0 miles** more or less miles.
9. The Contractor shall apply the paint at a time of low traffic volume.

10. The Contractor's equipment shall have adequate warning lights to warn the vehicular traffic of the work in progress.
11. The Contractor shall submit to the County with this bid a Certification of the Contractor's Liability Insurance verifying the following amounts: General Liability of \$1,000,000.00; Personal Injury of \$500,000.00; Medical Expense of \$5,000.00; Each Occurrence of \$500,000.00.
12. The Contractor shall be paid by the "Gallon Applied" method, which is to include reflective beads.
13. The Contractor shall have all striping work completed by June 15, 2023.

Sealed Bids will be received by the Road and Bridge Committee of Dodge County, hereafter called the Owner, in the office of the Dodge County Highway Department, Rm. 204, 2nd Floor of the Courthouse, Fremont, NE at 11:00 A.M. Local Time on the 6th day of February, 2023 and then at said office publicly opened and read aloud.

Each Bid shall be submitted in a sealed envelope addressed to the Dodge County Clerk, 435 N. Park, Fremont, NE 68025. Each sealed envelope containing a bid must be plainly marked on the outside as bid for **DODGE COUNTY HIGHWAY DEPARTMENT 3/4 TON RATED 4X4 EXTENDED CAB PICKUP**, and the envelope shall bear on the outside the name of the Bidder and their address. Each bid shall be time stamped on the outside of the envelope at the County Clerk's Office prior to opening time.

Each Bid shall be accompanied with a Certified Check in the amount of \$100.00 made payable to the Dodge County Highway Department. Failure to submit the \$100.00 Certified Check shall render this Contract null and void. The Certified Check shall become the property of Dodge County if any part of this Contract and Specifications is violated or omitted. Check shall be returned to the Bidder when all items of this Contract and Specifications is complete.

All bids shall be submitted on the Contract and Specifications form supplied by the Dodge County Highway Department. All blank spaces to be bid shall be filled in with ink or typewritten and the bid form shall be fully completed and signed prior to opening time. Any bid received after opening time shall not be considered.

Each Bidder is responsible for reading and being thoroughly familiar with the Contract and Specifications. The failure or omission of any bidder to do any stipulations in the Contract and Specifications shall in no way relieve the bidder from any obligation in respect to his bid. After bids have been submitted, the bidder shall not assert that there was misunderstanding concerning the requirements of the Contract and Specifications.
