# MINUTES DODGE COUNTY PLANNING COMMISSION

Meeting of the Dodge County Planning Commission was called to order by Chairman, Marlin Brabec at 4:30 P.M., Tuesday, January 17, 2023 in the Board of Supervisors Room on 3rd Floor of the Courthouse, Fremont, Nebraska. The following members were present: Brabec, Fooken, Giesselmann, Hansen, Rolf, Taylor, Wagner and Weitzenkamp. Absent: Ruzicka.

The meeting was declared legally convened, due to Public Notice given and is considered to be an Open Meeting. No Exparte had been reported.

Motion was made by **Fooken** to accept the Minutes of the December 20, 2022 meeting as mailed. Seconded by **Rolf.** Motion carried by voice vote with the following voting yes: Fooken, Giesselmann, Hansen, Rolf, Taylor, Wagner, Weitzenkamp and Brabec. Absent: Ruzicka.

Chairman Brabec declared the public hearing to be open.

**Public Hearing**: Consider request of Kenneth, Sandra and Kevin Hasemann of 1 Pioneer Lake, North Bend, NE 68649 to subdivide a 6.55- acre tract and obtain a Conditional Use Permit for an existing dwelling as per Article 12 Section 2. Conditional Uses 4.2 Exemptions B. located in part of SW ¼ and part of NW ¼ of Section 22, Township 19 North, Range 7 East in Everett Township, Zoning District A-1, Intensive Ag.

# Testimony:

**For:** Kenneth Hasemann was present to explain the request. He stated they had recently purchased the quarter of section farm ground and it has an acreage on it that he wishes to sell to his son to raise show pigs. Brabec asked Andrews if she had received any communication regarding the proposal. Andrews state no oral or written communication had been received.

No further questions were asked by the commission.

No additional person spoke for the request.

**Against:** No written or verbal communication had been received.

Motion to close the hearing was made by **Hansen** and seconded by **Taylor.** Motion carried by voice vote. All present voted yes.

Motion was made by **Giesselmann** and seconded by **Weitzenkamp** to recommend approving the Lot Split and Conditional Use permit based on the Conditional Use conforms to the intent and purpose of the regulations and the use conforms to regulations of the district which it is located. Motion carried by roll call vote. Those voting yes: Giesselmann, Hansen, Rolf, Taylor, Wagner, Weitzenkamp, Brabec and Fooken. Absent: Ruzicka. Mr. Hasemann was advised the Dodge County Board of Supervisors would hear the request on January 25, 2023 at 9:30 A.M.

Andrews stated she had been requested to bring the regulations to the planning commission due to the possibility of requests for a Wind Farm. She added that she would be happy to make any changes that the board would bring to her. Wagner stated that he was on his way to Denver when he received the packet and didn't have a chance to read it before this meeting. Brabec stated he thought that obtaining information from either Omaha Public Power, Fremont Department of Utilities or possibly Lincoln Electric would be helpful. He added that we (the board) were not experts on the conciseness of this type of regulations. Wagner stated that he had heard that a farmer could have a contract for a wind farm that covered 25 years and the contract could be \$15,000.00 to \$27,000.00 per site, so we need to do this right. Brabec stated that the University of Nebraska could possibly be contacted for information regarding the regulations.

Motion to continue the item and contact an unbiased person or company for assistance was made by **Wagner** and seconded by **Rolf**. Motion carried by voice vote. All present voted yes.


