HUB (Silverstone) Actuarial Report - Glen Gahan presented the January 1, 2023 Actuarial Valuation Report for the Fremont Health Restated Pension Plan. The Valuation was prepared to determine the value of accrued benefits and annual plan costs. In addition, Mr. Gahan shared yearly plan projections to 2053 with a 3.5% & 4.5% investment return and a 2.0%, 4.0% and 6.0% Termination Liability based on the Market Value of Assets at December 31, 2022. Mr. Gahan shared an estimate of the assets required to settle the liability of the plan as of February 1, 2023. Further discussion was held on plan assets and liabilities.

FNBO Investment Update - Todd Seawall and Stacy Auman with FNBO presented a Portfolio Overview of Pension Investments as of January 31, 2023. Discussion was held regarding the asset allocations per the Investment Policy and directed FNBO to invest within the current allocations.
