The Tax Equalization and Review Commission has received the notice of your appeal to the Nebraska Court of Appeals. As the petitioner, you are required to pay the cost for the preparation of the official record pursuant to Neb. Rev. Stat. § 77-5019(4).

Before preparation of these documents can begin, a check for the estimated cost of preparation of the transcribed record of the hearing must be made payable to **General Reporting Service, Inc.** in the amount of **\$620.00** and sent to the Commission's office. This amount includes the cost of transcribing the August 25, 2022, hearing and the cost of preparing the exhibits as required by the court rules. If the actual cost exceeds the amount estimated, you will be billed for the remainder of the cost before the Commission delivers the records to the Court of Appeals. If the actual cost is less than the amount estimated, General Reporting will reimburse you accordingly. The cost of the preparation of the pleadings and similar documents will be billed separately.

Once the prepared Bill of Exceptions is received from General Reporting, we will e-file it.

Please make your payment as soon as possible to ensure that the record is prepared by the date established by the Court.
