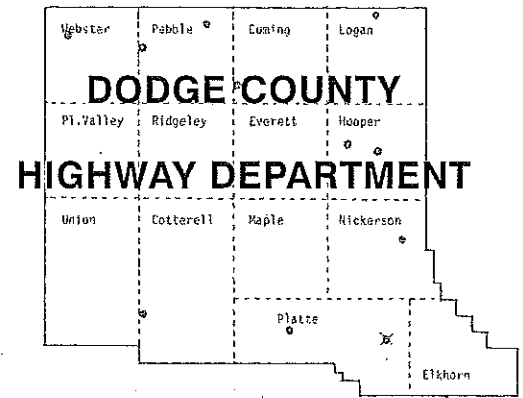


Mr. Chairman:
