Attached is your National Pollutant Discharge Elimination System (NPDES) Individual Permit renewal for the above referenced concentrated animal feeding operation. The permit includes a date when the permit will expire; however, the permit may be modified or reissued prior to that date to reflect regulatory changes or modifications to the operation. An application for renewal of this permit must be received by the Nebraska Department of Environment and Energy (Department) a minimum of 180 days prior to permit expiration unless permission for submittal at a later date has been granted by the Director.

In accordance with Title 130, Livestock Waste Control Regulations, this permit includes specific operational, monitoring, reporting and record keeping requirements that must be followed to remain in compliance.

As a condition of this permit and Title 130, the Permittee, authorized representative or an employee of the operation is required to obtain land application training. Land application training is required for your operation within 180 days of receiving permit coverage from the Department, unless such training was satisfactorily completed within the past five (5) years by at least one of the persons required above to obtain the training. Department records indicate your current training is valid until March 30, 2022. Additional training is required every five (5) years.

Issuance of an NPDES Permit by the Department does not relieve you of other duties and responsibilities under the Nebraska Environmental Protection Act, the amended Nebraska Livestock Waste Management Act or Title 130. Department staff will conduct periodic inspections of your operation to review compliance with permit conditions. Additionally, you are responsible for complying with any Natural Resources District, county or local zoning regulations. Violation of Title 130 regulations or NPDES Permit requirements may result in fines, civil or criminal penalties or removal of the livestock from the operation. You are responsible for preventing any unpermitted discharge of livestock waste to waters of the State.
