RESOLUTION
INTERLOCAL AGREEMENT
BETWEEN
DODGE COUNTY, NEBRASKA
AND

PEBBLE TOWNSHIP IN DODGE COUNTY, NEBRASKA
FEMA PROJECT – 2019 FLOODING

WHEREAS: Certain roads and streets in Pebble Township which have been designated as Township roads suffered severe damage during the flooding in the spring of 2019.

WHEREAS: Dodge County and Pebble Township in Nebraska, desire to work together in an effective manner.

BE IT RESOLVED: That the Dodge County Highway Department is hereby requested to act for Pebble Township, Nebraska and to program for construction road and culvert repairs previously documented.

Dodge County will proceed with the preparation of construction plans and specifications. It is proposed to let the projects to contract.

BE IT FURTHER RESOLVED: That the Chairman of the Board of Dodge County is authorized to sign this agreement on behalf of Dodge County and the Chairman of Pebble Township is authorized to sign this agreement on behalf of Pebble Township and that both entities hereby approve the contemplated construction.

BE IT FURTHER RESOLVED: That sufficient funds of Dodge County and Pebble Township are now, or will be, available and are hereby pledged in the amount and at the required time to proceed with a 2020-2021 project construction.

BE IT FURTHER RESOLVED: That Dodge County will be responsible for coordinating the work with FEMA and will assist in obtaining FEMA reimbursements on behalf of the Township.

BE IT FURTHER RESOLVED: That Dodge County will assist the Township with obtaining an engineering firm to conduct preliminary and final design and construction oversight. A Request for Proposals (RFP) for this work will be sent out. Upon receiving responses to the RFP, the Dodge County Highway Superintendent will meet with the Township and a final selection will be made.

BE IT FURTHER RESOLVED: That the Dodge County Highway Superintendent is hereby requested to act for all correspondence and certifications required with NEMA and FEMA.
