**RESOLUTION OF THE DODGE COUNTY BOARD OF SUPERVISORS
AUTHORIZING CHIEF ELECTED OFFICIAL TO SIGN AN APPLICATION
FOR COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDS**

Whereas, Dodge County, Nebraska, is an eligible unit of a general local government authorized to file an Emergent Threat application under the Housing and Community Development Act of 1974 as amended for Small Cities Community Development Block Grant Program, and,

Whereas, Dodge County, Nebraska has obtained its citizen's comments on community development and housing needs and has conducted public hearing(s) upon the proposed \$485,000 CDBG application and received favorable public comment respecting the application which for an amount of \$450,000 will be used for Drainage/Flood Control of Breach Lake-Fremont Rod and Gun Club. Other grant funded project costs will include: \$10,000 will be used for construction management; and \$25,000 will be used for general administration. Dodge County has committed to providing up to 30% of required local matching funds , not to exceed \$50,000. The remaining matching funds will be provided by the City of Fremont, Lower Platte North NRD, and Fremont Rod and Gun Club. The estimated total program cost is \$612,380.

NOW THEREFORE BE IT RESOLVED BY the Board of Supervisors of Dodge County, Nebraska that the Board Chairman be authorized and directed to proceed with the formulation of any and all contracts, documents or other memoranda between Dodge County and the Nebraska Department of Economic Development so as to effect acceptance of the grant application.

NOTICE OF PUBLIC HEARING ON APPLICATION FOR COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM

NOTICE IS HEREBY GIVEN that on June 17, 2020 on the Third Floor, Courthouse, Fremont, Nebraska the Dodge County Board of Supervisors will hold a public hearing concerning an application to the Nebraska Department of Economic Development for a Community Development Block Grant. This grant is available to local governments for community/ economic development activities.

Dodge County is requesting \$485,000 for Emergent Threat Disaster Funds for flood damage repairs of the Breach Lake flood protection structure on land owned by the Fremont Rod and Gun Club. The total estimated project cost is \$612,380, with CDBG funds requested and project activities will include \$450,000 Flood Control and Drainage; \$10,000 Construction Management; and \$25,000 General Administration. Matching and leverage funds of \$162,380 will be provided by units of local governmental Corps of Engineers and Fremont Rod and Gun Club. This project will meet the Emergent Threat National Objective. The project will repair an existing flood control structure on recreational land, there will not be displacement of people as a result of the CDBG activities.

The grant application will be available for public inspection at Dodge County Courthouse Clerk's Office. All interested parties are invited to attend this public hearing at which time you will have an opportunity to be heard regarding the grant application. Written and oral testimony will also be accepted at the public hearing scheduled for 9:30 A.M., June 17, 2020, Third Floor, Courthouse, 435 N Park, Fremont Ne. Written comments addressed to Fred Mytty at 435 N Park, Fremont, NE 68025 will be accepted if received on or before June 17, 2020.
