Environmental Land Management leases agricultural land from Donald Witte and John Havekost to stockpile soil conditioner and fertilizer food byproducts. In response to your letter to Donald Witte and John Havekost, dated September 28th, 2020, I have enclosed the following documents:

- Soil Conditioner and Fertilizer Management Plan
- NDEE NPDES 2020 Permit Requirements for Land Application of Biosolids
- NDOA Fertilizer License
- NDOA Soil Conditioner and Fertilizer Labels
- Byproduct Delivery Records for Biomass, Gypsum, and Perlite at Site 650

We use an internal numbering system to identify our land application and stockpile sites. Your letter addresses gypsum stockpiling on Parcel ID #270114961, located near Scribner, NE in Section 16, Township 9N, Range 7E, which is labeled by Environmental Land Management as "Site 650". As of September 30th, 2020 there are 33,757.78 tons of Gypsum, 23,300.42 tons of Biomass, and 6926.61 tons of Perlite stockpiled in calendar year 2020 at Site 650 (all tonnage calculations are "as received" tons). As of September 30th, 2020 we have hauled out 5,424 tons for land application. Site 650 (241 Acres Spreadable), as well as neighboring Site 905 (529 Acres Spreadable) and Site 852 (399 Acres Spreadable), are all NDEE Permitted Sites.

Our land application season typically runs from October 15th-April 30th. At our agronomist recommended rate of 4 tons "as received" per acre we estimate, weather permitting, the current stockpile amount of 33,757.78 tons of Gypsum should be completely land applied in 35-43 working days.

In response to the odor complaint we will be conducting an odor study within the next few weeks using a Nasal Ranger Field Olfactometer. This will provide quantifiable measurements of any odors that may be coming off Site 650 at various distances. Our study will also include odor measurements that may be coming off commonplace agricultural practices, such as cattle feed production, livestock farming, and livestock manure storage.

We share the same goal of land applying all the byproducts stockpiled at Site 650 as soon as possible. For the past few years we have stockpiled various byproducts at Site 650 with the intention that all byproducts, weather permitting, will be land applied in the same calendar year. Over the past few years we have had success in diverting soil conditioner and fertilizer food byproducts from ending up as solid waste in a landfill. Recycling valuable soil conditioners and fertilizers has resulted in many local farmers saving on fertilizer costs at a time when every dollar counts.

THE DODGE COUNTY BOARD OF SUPERVISORS

A RESOLUTION CREATING REGULATIONS TO PROMOTE PUBLIC HEALTH, SAFETY AND WELFARE, AND PROVIDE RULES FOR THE PREVENTION, ABATEMENT AND REMOVAL OF NUISANCES IN THE COUNTY OF DODGE, NEBRASKA UNDER AUTHORITY GRANTED BY THE STATE OF NEBRASKA IN THE NEBRASKA REVISE STATUTES SECTION 23-174.10.

WHEREAS: The Nebraska Revised Statutes Section 23-174.10 authorizes the County Board of any county that has adopted zoning to make regulations as may be necessary or expedient to promote the public health, safety and welfare, including regulations to prevent the introduction or spread of contagious, infectious, or malignant diseases; to provide rules for the prevention, abatement and removal of nuisances, including the pollution of air and water, and make and prescribe regulations for the construction, location, and keeping in order of all slaughter houses, stockyards, warehouses, sheds, stable barns, commercial feedlots, dairies, junk and salvage yards, or other places where offensive matter is kept, or is likely to accumulate;

WHEREAS: The County Board of Dodge, Nebraska has adopted zoning and subdivision regulations and intends to exercise the authority granted to it under NRSS 23-174.10;

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of Dodge, County, Nebraska, that;

The most current revision of the Dodge County Zoning and Subdivision Regulations is hereby adopted as the means by which the Dodge County Board shall exercise the authority granted to it under NRSS 23-174.10. This regulation is to be considered amended at the same time as subsequent amendments are made to the Dodge County Zoning and Subdivision Regulations.

All of the land uses and building types listed in 23-174.10 which are in compliance with the Dodge County Zoning and Subdivision Regulations are to be considered in compliance with this resolution. Any land use or building type listed in 23-174.10 which is not in compliance with the Dodge County Zoning and Subdivision Regulations shall be considered to be in non-compliance with this resolution.

Enforcement of this regulation shall be provided by the Dodge County Planning and Zoning Administrator.

I represent the City of Scribner, Nebraska and the Mayor and Council have asked me to contact you in regard to a rather "smelly" problem that the city is experiencing due to the piling of a by-product of ethanal production near the Scribner Airport. It is my understanding that the material can be used on farmland as fertilizer. It is also my understanding that the company had previously stored such material on land in Washington County near Ft. Calhoun, and that the zoning authorities required them to move such storage out of Washington County. The storage of such material is on property owned by Donald Witte and John Havekost on Section 17, Township 19, Range 7 East of the 6th P.M., Dodge County, Nebraska.

The by-product material is located just North of the Scribner Airport, and when a south wind blows it carries the smell over the City of Scribner. The area is beyond the City of Scribner zoning jurisdiction.

It appears that this area is within your county zoning jurisdiction, and I am inquiring whether your zoning regulations control this type of situation. I would appreciate it if you would review the matter and let me know of possible remedies so that I may so inform the Mayor and City Council.


