I am submitting my study of the vacation of County Road U Blvd. and Road 29 located in the Southeast Corner of Section 14, Township 17 North, Range 9 East of the 6<sup>th</sup> P.M. This road is 33 feet in width and approximately 840 feet in length.

Elkhorn Township Board members request this road be vacated due to the construction of the Union Pacific Railroad bridge near this intersection.
