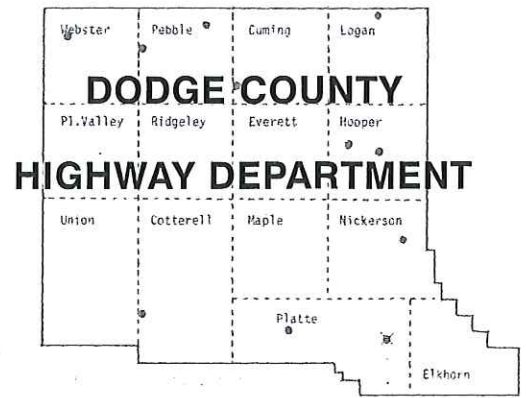


Honorable Members:

Supervisor _____ moved to adopt said Resolution.

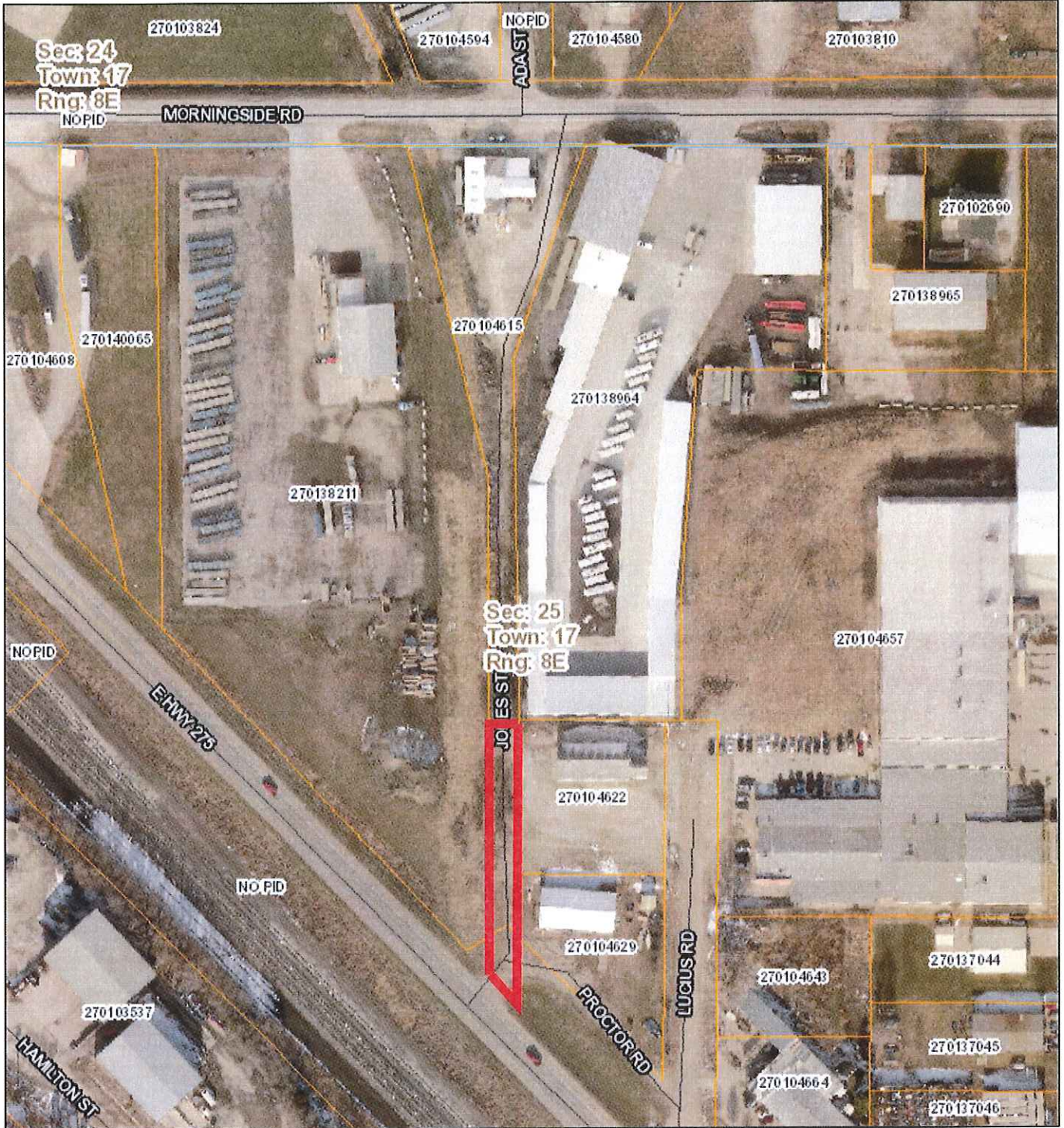

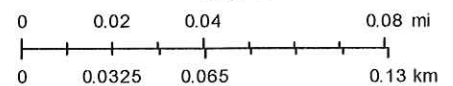
