The Dodge County Board of Supervisors are asking for sealed bids for Crushed Limestone Road Rock. Sealed Bids shall be opened June 10, 2022 at 11:00 A.M. in the office of the Dodge County Highway Department, 435 N. Park, Rm. 204, Fremont, NE.

This Bid form shall be the only bid form accepted by the Dodge County Board of Supervisors, any additions or deletions to this bid form shall be cause for rejection. This bid shall be time stamped by the Highway Department prior to opening time.

The crushed rock to be bid is listed below and shall be loaded at the Contractor's plant site into Dodge County trucks and weighed on State of Nebraska approved scales.

The bid price per ton shall be in effect from July 1, 2022 to June 30, 2023.

The amount of crushed limestone rock estimated for this Contract is 10,000 tons and is an estimate only; contractor agrees to produce same be it more or less.
