Under the provisions of Section 29-2259, Revised Statutes of Nebraska, 1943 (Reissued 1985), Burt County is required to pay a percentage of the expense for maintaining the offices of Nebraska Probation District Six (see attachment). Based upon the workload and population within the district, I have calculated Dodge County's financial responsibility at 40% of the overall budget. Please refer to an explanation of my calculations below.

The district's workload was determined through information obtained from the Nebraska Probation Management Information System. The workload of each county was calculated as a percentage of the district's workload. The district's population was determined through information obtained from the U.S. Census Bureau Website http://www.census.gov/. The population of each county was calculated as a percentage of the district's population. The percentage of each county's workload was averaged with the percentage of each county's population. The resulting percentages were used to determine the reimbursement amount for each county within District Six. The proportions effective July 1, 2019 are as follows:
