## 3. FINANCE & ACCOUNTING

Financial Statements - February 2023 - The February 2023 Financial Statements were distributed to the Board Members prior to the meeting.

### 4. METHODIST FREMONT HEALTH

Annual Report - Brett Richmond, President/CEO of Methodist Fremont Health presented the 2022 MFH Annual Report to the FCHR Board of Trustees. He reviewed the status of each of the seventeen Commitments of Tenant per the Lease Agreement between Fremont Community Health Resources and MFH. noted Methodist continues to provide \$3M annually for 'routine' capital and that Methodist Health System has committed an additional \$1.8M of the Strategic Capital for replacement of the MFH phone system. The Fremont Health Foundation provided an additional \$1.2M toward the First Floor Renovation. The total capital investment in Information Technology has been greater than \$5M. continues to provide all material services previously provided by Fremont Health. MFH will participate in the system-wide planning retreat this summer to update the existing MHS strategic plan for 2024-2026 and will then update its local MFH strategic plan for this same time Quality and Value is fully integrated with MHS. MFH continues to participate in the MHS Value Analysis Team/Structure with the goal of achieving \$14M in annual savings for MHS, including \$1M plus in annual savings for MFH continues to provide all Community Programs as previously provided by Fremont Health. MFH continues to receive a full corporate overhead allocation from MHS. 2022, several new physicians were recruited, the Pulmonary physicians transitioned to Methodist Physicians Clinic, and the Anesthesia providers transitioned to MFH employment. Employee benefits were enhanced with the addition of shortterm disability and other voluntary benefits in 2022. MFH continues to be included in the MHS branding campaigns and the "Meaning of Care" quarterly magazine. The MFH ninemember Board of Directors includes eight local Dodge County residents. MFH is represented on the MHS Board and Mr. Richmond shared several statistics and Committees. Financial indicators for 2022. He highlighted several 2022 accomplishments, including being recognized as a Top 100 Rural and Community Hospital by the Chartis Center for Rural Health. In 2021 MFH provided \$14.5M in Community Mr. Richmond was asked to get an update on the Benefits. CMS Volume Decrease Adjustment being pursued by the Rybar Group and its attorneys on behalf of MFH with any payments to be provided to FCHR.
