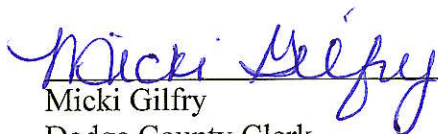

I furthermore certify that the attached list reflects the parcels in Dodge County sold by me for delinquent Real Estate Taxes.

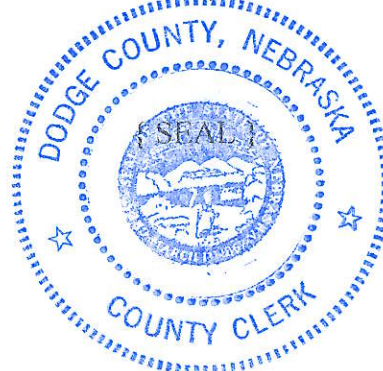
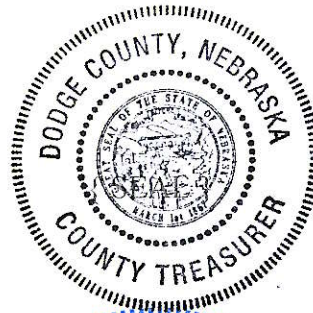
