

**NOTICE TO VOTERS ON FILING FOR OFFICE
FOR THE PRIMARY ELECTION, MAY 12, 2020**

From the office of County Clerk, Dodge County, Nebraska

Notice is hereby given that anyone wishing to file for office for the 2020 statewide Primary Election must do so by the following deadlines:

February 18, 2020 For present officeholders or incumbents of any other office.
March 2, 2020 Anyone else.

On both dates, the deadline is **5:00 P.M.**

County official candidates and other state office candidates are required to file a "Statement of Financial Interests" before their name could be placed on the ballot. The completion of this form should be considered when waiting until the last minute to file for office.

There is a filing fee of 1% of the annual salary for most offices, if the salary exceeds \$500 per year.

The following is a list of officials to be elected in 2020 and will appear on the May 12, 2020 Primary Ballot, unless there are automatic nominating procedures allowed for that race. The number in parentheses is the vacancies to be filled in 2020. If it's a nominating race, no more than twice that number will be forwarded to the General Election for non-political races and no more than one per party will advance to the General Election on partisan races. All candidates are elected to 4 year terms unless otherwise indicated.

Delegates to county conventions are no longer a county clerk/election commissioner function and will not appear on the Primary Election. However, political parties have given me registration forms available to the public to go to county conventions.

**AT THE STATE LEVEL BY FILING AT THE SECRETARY OF STATE'S
OFFICE, STATE CAPITAL, LINCOLN**

PARTISAN TICKET

United States President (Nomination) (1) (4 year term)

(Neb. Rev. Stat. §32-614 provides that the Secretary of State places candidates who are "generally advocated or recognized as candidates in national news media" on the primary election ballot in Nebraska. The Secretary of State's decision typically occurs in the middle of February during the election year.)

United States Senator (Nomination) (1) (6 year term)

Representative in Congress, District One (Nomination) (1) (2 year term)

NON-POLITICAL TICKET

Member of the Legislature, District 15, (Nomination) (1)

(This district covers all of Dodge County.)

Member of the State Board of Education, District 3 (Nomination) (1)

(This district covers a large area of northeast Nebraska from Washington County to the east and Platte County to the west and the South Dakota border on the north.)

Members of the Board of Governors, Metropolitan Community College Area, District One (Nomination) (1)

(This district covers all of Dodge, and areas of Douglas and Sarpy Counties.)

Directors of Nebraska Public Power District, Subdivision 9 (Nomination) (1) (6 year term)

(This district covers areas of most of rural Dodge County and areas of Butler, Colfax, and Platte Counties)

Public Power Districts which gross more than \$40 million go through a nominating procedure of the Primary Election for their Boards. Smaller PPD Boards only appear in the General Election.

Natural Resources Districts

For many natural resources districts (NRDs), candidates now file by subdistrict and are elected only by the subdistrict. Lower Platte North NRD has candidates file by subdistrict but the entire NRD elects them.

Directors of Lower Platte North Natural Resources District (Nomination)

(In Dodge County, this district covers the southern third of the county, including the Cities of Fremont & North Bend, and Platte & Elkhorn Twps., plus the southern parts of Union, Cotterell, Maple & Nickerson Twps.)

Subdistricts 1, 2, 3, 4, 5, 6, 7, 8, and 9 (1 in each subdistrict)

Directors of Lower Elkhorn Natural Resources District (Nomination)

Subdistrict 7 (Nomination) (1)

(In Dodge County, this district includes the cities of Hooper & Scribner, and Pebble, Cuming, Logan, Ridgeley, Everett, Webster, Pleasant Valley, & Hooper Twps., plus the northern parts of Cotterell, Maple, Union & Nickerson Twps.)

Directors of Papio Missouri River Natural Resources District (Nomination)

Subdistrict 5 (Nomination) (1)

(In Dodge County, this is just a small area of Elkhorn and Platte Twps.)

Educational Service Unit Board members, Cuming County Public Power District Board and Burt County Public Power District Board members are elected in the General Election, November 3, 2020. The filing deadline for running for these boards is July 15, 2020 for incumbents and August 3, 2020 for others.
