From the office of County Clerk, Dodge County, Nebraska

Notice is hereby given that on Tuesday, November 8, 2022, at the following polling places in the precincts of Dodge County, Nebraska, an election will be held. The polls will open at 8:00 A.M. and will close at 8:00 P.M.

Said election will be held for electing candidates to various offices.

All voters will be given 2 State Initiatives to consider, Voter ID Constitutional Amendment (Initiative Measure 432) and Minimum Wage Initiative (Initiative Measure 433), and Proposed Constitutional Amendment 1.

A true copy of the ballot title and text of the initiative and Proposed Constitutional Amendment will be published by the Secretary of State once each week for three consecutive weeks preceding the election.
